		<p>Test and Trace to take a PCR test and will only need to isolate if they produce a positive test.</p> <ul style="list-style-type: none"> <li>• Pupils and parents are made aware that fully vaccinated adults who are identified as a close contact of a positive case do not need to self-isolate unless they develop symptoms or produce a positive test, as long as they are fully vaccinated.</li> <li>• Staff who have only had one dose of the vaccine are made aware that they still need to self-isolate if identified as a close contact until two weeks after receiving their second dose.</li> <li>• Instances of staff, pupils, visitors and volunteers displaying symptoms of coronavirus are managed in line with local and national guidance and the Infection Control Policy.</li> <li>• Pupils and parents are made aware that staff and students over the age of 18 should follow the same self-isolation rules as those under 18 until four months after their 18<sup>th</sup> birthday, at which point they will begin to follow the same rules as adults. This time should be used to ensure they are vaccinated if possible.</li> <li>• If anyone in the school develops coronavirus symptoms while at school, they are: <ul style="list-style-type: none"> <li>- Sent home to begin isolation – the isolation period includes the day the symptoms started and the next 10 full days.</li> <li>- Advised to follow the guidance for households with possible or confirmed coronavirus infection.</li> <li>- Advised to arrange a PCR test as soon as possible.</li> </ul> </li> <li>• Pupils being sent home after displaying symptoms who are awaiting collection by a parent are moved to a room where they can be isolated behind a closed door, with an open window for ventilation where possible. If it is not possible to isolate the pupil, they are moved to an area which is at least two metres away from others. If required, a member of staff supervises the pupil.</li> </ul>

		<ul style="list-style-type: none"> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in government guidance and the Infection Control Policy.</li> <li>• In exceptional circumstances, where a pupil's parents cannot arrange to have their child collected, if it is age-appropriate and safe to do so, the child is directed to walk, cycle or scoot home. If this is not possible, the school makes alternative arrangements.</li> <li>• Symptomatic individuals who are sent home are directed to not use public transport to get home.</li> <li>• If the pupil needs to use the toilet while awaiting collection, they use a separate bathroom if possible. Face coverings		<ul style="list-style-type: none"> <li>• Staff and pupils are informed via email that they are to wear masks in communal areas and on school buses.</li> <li>• In the event of a school or local outbreak, the school adheres to advice from a director of health that may include bringing back face coverings temporarily in communal areas and classrooms for staff, pupils and visitors. Updated to – all staff, pupils and visitors at the College site should wear a face covering in corridors. 21.09.21</li> <li>• Advice from UK Government Health Security agency 17.11.21 - recent robust updated evidence supports the use of face coverings in reducing transmission in non-healthcare settings, through a combination of source control and protection to the wearer. Transmission of COVID is impacted by ventilation, length of exposure and activities that generate more aerosols such as shouting. Face coverings worn in communal spaces (such as hallways, stairwells and lunch queues) in areas of high prevalence may be beneficial to reduce transmission and will have limited impact on education delivery.
